## LOI CONTENT

Per the 2018 MHDC's Developer's Guide (<a href="http://www.mhdc.com/rental\_production/2018-fy-items/FY2018-DG-ii.pdf">http://www.mhdc.com/rental\_production/2018-fy-items/FY2018-DG-ii.pdf</a>), Letters of Intent from service providers anticipated to participate in the development's services program, should include the following content:

- a. Name of the service or program
- b. The nature of the services or program
- c. Service delivery plan
- d. Duration of commitment
- e. Primary contact person with signature

MHDC requires specific reference within the LOI be made as follows:

- (1) Indicate your LOI is between your organization and Belmont Management Company for delivery of services to the residents of GardenWalk at Magnolia Ridge in Warrensburg, MO, for the duration of the fifteen (15) year Compliance Period or at a minimum for a period of three (3) years;
- (2) In regard to items b, c, and d as mentioned above, list the specific services your organization will provide to the residents and indicate in detail the delivery method of each service, the timing of delivery of services (e.g., once per week, bimonthly, quarterly, etc.), and if the services will be delivered on-site or at what location. The goal is for services to be delivered on-site at the GardenWalk at Magnolia Ridge, Warrensburg Community Building/Clubhouse.
- (3) The LOI must indicate whether or not the services are being provided to the residents of GardenWalk at Magnolia Ridge free of charge or if there is a charge, the amount being charged for said service.
